- (iv) The real estate agent shall not involve himself in any unfair trade practices as specified under Section 10 (c) of the Act;
- (v) The real estate agent shall facilitate the possession of all information and documents, as the allottee is entitled to, at the time of booking of any plot, apartment or building, as the case may be;
- (vi) The real estate agent shall provide assistance to enable the allottees and promoters to exercise their respective rights and fulfill their respective obligations at the time of booking and sale of any plot, apartment of building, as the case may be.

(vii) The real estate agent shall not contravene the provisions of any other larger for the time being in force as applicable to him;

(viii) The real estate agent shall discharge such other functions as  $m_{ay}$  by specified by the Authority by regulations;

The registration is valid for a period of five years commencing  $f_{\text{reg}}$  22.12.2017 and ending with 21.12.2022.

In case, any of above mentioned conditions stands violated by the restate agent at any time, the Authority may take appropriate action against the restate agent including revoking the registration granted to him, as per the provisi of Act and the rules and regulations made thereunder.
