- (vi) The real estate agent shall provide assistance to enable the allottees and promoters to exercise their respective rights and fulfill their respective obligations at the time of booking and sale of any plot, apartment or building, as the case may be.

(vii) The real estate agent shall not contravene the provisions of any other la for the time being in force as applicable to him;

(viii) The real estate agent shall discharge such other functions as $m_{ay\ b}$ specified by the Authority by regulations;

The registration is valid for a period of five years commencing $\mathfrak{f}_{\mathbb{N}}$ 22.12.2017 and ending with 21.12.2022.

In case, any of above mentioned conditions stands violated by the restate agent at any time, the Authority may take appropriate action against the restate agent including revoking the registration granted to him, as per the provision of Act and the rules and regulations made thereunder.
